

Roller Skating Waiver and Consent Form

RALLY 2026 | Wednesday, October 14, 2026 | Meridian Hall, 1 Front St E, Toronto

How this form works

SKATEVAN is running a roller skating activation at RALLY, a school field trip for students in Grades 9 to 12. Skates and helmets are provided. Students cannot skate without a signed form.

A parent or legal guardian reads this form, completes the box on the last page and signs. Students who are 18 or older sign for themselves.

Bring this signed form to RALLY and hand it in at the SKATEVAN booth to receive your skates and protective gear.

Please read this carefully. It affects your legal rights. In this form, **“the student”** means the student named on the last page and **“I”** means the person signing.

1. Understanding the risks

Roller skating involves risks, including falls, collisions and contact with other skaters, equipment or surfaces. These can cause injury, and in rare cases serious injury or death. I accept these risks on behalf of the student and agree that the student takes part voluntarily.

2. Helmets and instructions

Helmets are mandatory. SKATEVAN provides a helmet and the student must wear it, properly fastened, at all times while skating. Knee pads, elbow pads and wrist guards are also available and recommended. The student will follow the directions of SKATEVAN staff and skate only in the designated area. Staff may end a student's participation at any time for safety reasons.

3. Health and fitness to participate

To my knowledge, the student has no injury, medical condition or other condition that would make roller skating unsafe for them or for others. I will tell SKATEVAN staff before the activity if anything changes.

4. Release of liability

In exchange for the student being allowed to take part, I release and agree not to make any claim against Retro Rolla Skate Club Inc. (doing business as SKATEVAN) and OFFLINE EVENTS LTD. (the organizer of RALLY), together with their directors, officers, employees, volunteers, agents, insurers, successors and assigns (together, the “Released Parties”).

This release covers any loss, damage, injury or expense the student or I may suffer in connection with the student's participation in roller skating at RALLY, including loss caused by the negligence of

the Released Parties, and including the risk of illness, personal injury or death. It applies to me, the student, and our heirs, next of kin, executors and legal representatives.

5. Indemnity

I agree to indemnify and hold harmless the Released Parties from any claim, demand, cost or expense, including reasonable legal fees, brought by or on behalf of the student or arising from the student's participation, except to the extent caused by the wilful misconduct of a Released Party.

6. General

This form is governed by the laws of Ontario. If any part is found to be unenforceable, the rest remains in effect. I have read and understood this form and am signing it freely. If the student is under 18, I confirm that I am their parent or legal guardian and have the authority to sign on their behalf.

Complete and sign

One form per student. A parent or legal guardian signs for students under 18. Students who are 18 or older sign for themselves. Hand the signed form in at the SKATEVAN booth on October 14 to receive your skates and protective gear.
